# I. Introduction

## 1. About JDS Scholarship

The Project for Human Resource Development Scholarship (JDS) was launched by the Government of Viet Nam with the assistance of the Government of Japan in 2000.



From the People of Japan

JDS is funded by the Government of Japan through its ODA (Official Development Assistance) budget.



JDS targets young public employees and others who are expected to play a leadership role in the development of their countries.



JDS provides scholarships to Viet Nam public employees to pursue two-year Master' Degree Courses (instructed in English) and 3-year Doctoral Degree Courses (instructed in English or Japanese, selection procedure in English) at Japanese accepting universities.

### Objectives of JDS

- To support Human Resource Development**  
JDS's objective is to strengthen the public administrative capacities in Viet Nam through providing the opportunity to obtain the Master's and Doctor's Degree to the young capable public employees who are expected to engage in formulating and implementing social and economic development plans and to play a leadership role in the development of the country.
- To Enhance Bilateral Relationships**  
JDS fellows are expected to solidify foundations to further bilateral relations with Japan by utilizing their human network developed through academic and social activities while in Japan.

### Beneficiaries of JDS

- For the participants (JDS Fellows)**  
JDS Fellows will acquire expertise to use for policy making and institutional building for the development of their country, and also build human network in and out of Japan through their study in Japan.
- For the organizations (The Fellows' workplace)**  
The Fellows' workplace will attain highly capable and motivated returnees (JDS Fellows) who can effectively contribute to the organizational missions.
- For the Country (The Fellows' country)**  
The Fellows' country will improve the institutional capability of the target organizations which foster the country's development.

## 2. System of JDS Viet Nam

The framework of the JDS Project under the "New System" was made applicable to Viet Nam in 2009 and was revised in 2013, 2017 and 2021. The new approach gives its importance on "selection and concentration" on the target priority issues to enhance effectiveness and efficiency of the program. A single program (One phase) is designed to accept four batches of Fellows (Fellows in each fiscal year constitute one batch). This year's application is for the 4<sup>th</sup> batch in phase 4.

The new JDS Project consists of the sectors called "Sub-Program" and "Component", which correspond to and deal with the selected target priority areas and the relevant development issues, which were confirmed as indispensable to the economic and social development of the country.

The Fellows of the JDS Project are selected from state organizations whose mission is closely related to the target priority areas (Sub-Program) and the relevant development issues (Component).

**Sub-Program 1**  
(Target Priority Area)



Accepting universities are Japanese universities which offers educational programs relevant to the needs of Viet Nam. For Master Program, accepting universities are fixed under each Component, the course period is **2 years**, and the medium of instruction is **English**. For Doctoral Program, accepting universities are not fixed, the course is for **3 years in English or Japanese**.

### 3. JDS Operating Committee (OC)

JDS Operating Committee (OC) is the decision-making committee of JDS Project. It consists of both members of Viet Nam and Japanese governments. The OC not only sets the framework and selection policies but also evaluates candidates in a selection round.

### 4. Award Benefits

The awards are offered for the stipulated period necessary for the Fellows to complete the academic program specified by JDS Project. The following benefits generally apply:

- Arrival allowance
- Accommodation allowance

  - Initial settlement of your life in Japan
  - Emergency situation etc.

### 5. Important JDS Rules

JDS has specific rules in order to realize its project goals and to ensure favorable study environment for the Fellows.

#### Before departure

- JDS Fellows must submit a JDS pledge to the Operating Committee to commit themselves to follow JDS Rules.

#### During the stay in Japan

- The Fellows are allowed to bring their family members to Japan only after 3 months from the date of arrival. (Some universities may have their own regulations about bringing family members to Japan)
- The Fellows are prohibited from:
  - Working (But working as Tutor, Teaching Assistant or Paid Internship is acceptable)
  - Driving motor vehicles, and
  - Applying for further studies such as a doctoral course while they are in Japan
- The Fellows must complete the study within the predetermined period of study and return to his/her country immediately after the study completion.
- If the Fellow is subject to disciplinary action by the University or has no prospect of academic attainment within the predetermined period of study for any reason such as poor grades, family issues, health issues and etc., payment of scholarship shall be cancelled, and the Fellow shall return to Viet Nam based on the decision/guidance of the University and the Operating Committee.

#### After returning to the home country

- The Fellows must attend a report session held by the Operating Committee.
- The Fellows are obliged to return and work for belonging organization in Viet Nam for at least twice the study period in Japan in compliance with the Pledge required by the Ministry of Education and Training.

Further details will be explained in an orientation conducted after the selection.

Background and Needs	<p>Viet Nam sets a governmental target of industrialization by 2020 in its "Socio-economic Development Strategy (2011 - 2020)" and "Socio-economic Development Plan (2011 - 2015)". These plans place a focus on sustainable growth of the nation through enhancing global competitiveness and capacity building of administrative officials in order to achieve an international integration and stability of society. Moreover, "Human Resource Development Strategy (2011 - 2020)" emphasizes cultivation of administrative officials capable of coping with changes in the world with the goal of global integration. It also focuses on strengthening administration, policymaking, and international laws as prioritized areas.</p> <p>In order to achieve the national target of industrialization by 2020, Viet Nam needs to develop internationally competitive private sector. To this end, various economic institutions should be improved, and their operation system is necessary to be strengthened to meet the needs of market economy and WTO rules. However, while such economic institutions have improved to some extent, they have not been perfectly operated and human resources to maintain the system need more capacity development.</p> <p>In this sector, JDS project aims to promote international economic integration and trade facilitation, to implement and operate various economic systems required in the course of the transition from planned to market economy, and to foster human resources responsible for modernization of the finance sector through strengthening the function of the State Bank.</p>

<b>Background and Needs</b>	<p>For achieving sustainable economic growth, Viet Nam should deal with increasing demand for transportation and rapid urbanization. Further, it requires improvement of transportation network that contributes to smooth and safe distribution of goods as well as human mobility. This improvement should be achieved through further development of physical infrastructure such as roads, railways, seaports and airports. Moreover, Viet Nam has to deal with other issues such as development and quality control of human resources to operate and maintain the increasing property for transportation, improvement of institutions to make use of private sector resources, means for traffic safety, and formulation of long-term strategy to develop transport sector.</p> <p>In this sector, the JDS project aims to foster human resources responsible for strategically important infrastructures and managing urban transportation systems which support sound development of urban cities.</p>

<b>Background and Needs</b>	<p>Energy consumption and the maximum amount of electricity in the past 5 years in Viet Nam grew on average 10 % per year, which was faster than its economic growth rates. Demand for electricity was 198,000GWh in 2017, and is currently estimated 350,000GWh in 2025 (1.8 times higher). Also, Viet Nam had been shifted to a net energy-importing country around 2015. In order to achieve long-term sustainable economic growth, new energy sources and electric transmission and distribution networks should be developed to help promote electricity supply. It is also important to increase varieties of energy sources for stable electricity supply, develop primary energy and promote energy saving.</p> <p>In this sector, JDS project aims to foster human resources responsible for formulating comprehensive energy policies, maintaining power generation infrastructure, and designing technical and safety standards.</p>

<b>Background and Needs</b>	<p>Viet Nam has achieved rapid economic growth since the launch of Doi Moi in 1986, partly driven by robust growth of the manufacturing sector in which FDI's inflow has been huge thanks to Viet Nam's cheap labour costs. However, economic growth has been slowing down over the last 20 years due to a lack of innovations and low and declining labour productivity. The value-added products created by the manufacturing sector are still low due to various factors, one of which is the unskilled labour force in the manufacturing sector. In order to achieve industrialization with higher value-added manufacturing, Viet Nam's manufacturing sector needs high quality human resources including highly skilled workers, practical engineers, and corporate managers.</p> <p>However, the vocational education and training (VET) institutions cannot necessarily provide sufficient training programs which satisfy the requirement of the industries due to the lack of experience and techniques of tutors and insufficient budget to update the training equipment.</p> <p>In addition to training the capable skilled workers in Viet Nam, as a current trend, both Vietnamese and Japanese Governments tend to put more and more focus on nurturing the Vietnamese industrial human resources in Japan under the framework of Japanese technical intern training program and specified skilled worker.</p> <p>Therefore, in order for JICA to support skilling immature labour force in Viet Nam in more effective way, nurturing the capable human resources of the Vietnamese Government and relevant public agencies that are involved in the above-mentioned policy implementation is imperative.</p>

<b>Background and Needs</b>	<p>Agriculture, forestry and fisheries industries are still important in Viet Nam, accounting for approximately 14.7% of the GDP and 37.7% of the working population, although its industrial structure has been changing because of economic growth. However, the income level of rural population which consists of approximately 70% of the nation's population remains low, and the gap of living standards between urban and rural areas is widening. Moreover, Viet Nam has not achieved global competitiveness in agriculture due to inadequate quality and safety assurance for their products. Thus, innovation in techniques for agriculture and generating additional values in their products are vital to the sustainable development of agriculture and rural areas.</p> <p>In this sector, the JDS project aims to foster human resources who contribute to modernizing techniques for agriculture, utilizing local resources such as land and water, and vitalizing rural communities and agricultural economies.</p>

<b>Background and Needs</b>	<p>Although health care services have been improving, issues such as the quality of health services, urban and local disparities, high medical expense, and rapid aging population are emerging, and measures are needed to achieve universal health coverage (UHC). It is essential for Vietnam to swiftly establish a sustainable health insurance system with the long-term perspective.</p> <p>Viet Nam has been exposed to a variety of emerging infectious diseases and the government regards preparedness of infectious diseases outbreaks as one of the priority issues. An effective health system will be important in the post-corona era, which can help build resilience by minimizing the impact of infection as well as social and economic development.</p> <p>In this sector, the JDS project aims to foster human resources who contribute to build health policy and social security system.</p>

<b>Background and Needs</b>	<p>Viet Nam is one of the nations which are likely to suffer severe impacts caused by climate change such as saltwater intrusions in Mekong Delta through rising sea levels and increasing typhoon damages in midland regions. Moreover, the country faces various challenges, because of the recent economic growth, including increased greenhouse gas emissions due to the rising energy consumption, air and water pollution, increasing waste products, and loss of biodiversity on account of inappropriate land use.</p> <p>In this sector, JDS project aims to foster human resources who contribute to policymaking and its operation in order to accommodate and reduce climate change, as well as to handle urban environmental issues, sustainable forest administration, conservation of biodiversity, and disaster prevention.</p>

<b>Background and Needs</b>	<p>Viet Nam implements legal and judicial reform towards 2020 but there are remaining problems such as inconsistencies among legal documents and arbitrary enforcement of laws and lack of capacity of civil servants. As for the law enforcement, Viet Nam doesn't have enough capacity to cope with newly emerging issues such as cyber security and maritime security. 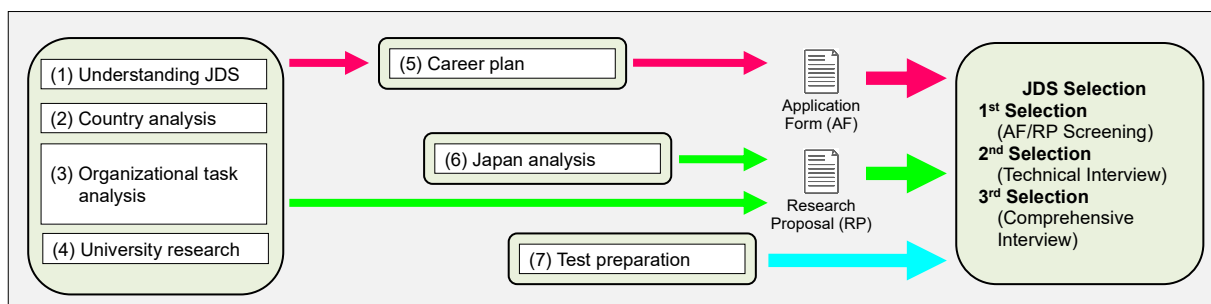

JDS Project Office in Viet Nam recommends submitting the Application Documents at least a week earlier than the application deadline to avoid any technical difficulty due to access overload.

## 5. Tips on Application and Selection (Reference)

The better you prepare for the Application Documents, the more chances to pass the selection you have. Here are some tips on the preparation of Application Form (AF) and Research Proposal (RP).



### About the selection and criteria

As shown in the chart above, you are advised to collect detailed information about JDS, Japan and the universities through literature survey and so on before challenging the JDS. Also, it is important to know in advance about its selection and evaluation criteria (P18) and prepare your application documents and RP with a view to winning the selection.

### (1) Understanding JDS

#### Objectives and framework

The objectives of JDS are written in P2. “Sub-Program and Component (SP/CP)” are shown in P5~P15. Most importantly, you have to note the reasons why JDS is provided to the public sector, why SP/CP are set in the JDS framework. The answers to those questions will be an important basis in making preparation for AF and RP.

- JDS is designed to support the human resource development of Viet Nam.
- The public sector can directly and widely contribute to the development.
- SP/CP are set based on the development plan of the Government of Viet Nam and Japan aid policy.

### (2) Country analysis

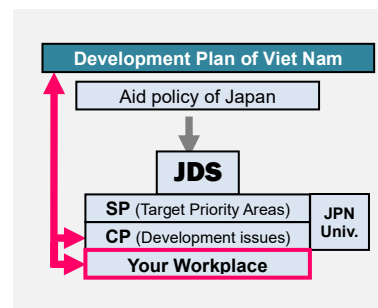
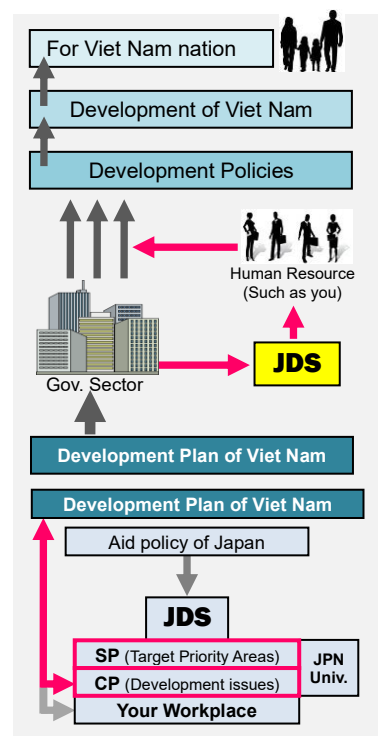
As mentioned in “(1) Understanding JDS” above, “SP/CP” is set based on the development plan of the Government of Viet Nam (Socio-Economic Development Plan (SEDP), etc.). First, read and understand the background of the SP/CP you wish to apply for (P5~P15) to know what kind of development issues are assumed and what kind of research are expected under JDS. Then, obtain information on development issues of Viet Nam (SEDP, Issues of your organization, etc.) to deepen your understanding of the status of the development. This analysis of present development status will be important not only for making a RP but also for later selection steps (interviews).

- Read and understand the background of the SP/CP you apply for (P5~P15)
- Check such materials as SEDP, issues of your organization, etc.

### (3) Organizational task analysis

It is essential for you to know what kind of mission your organization has in the context of the development of Viet Nam. Also, it is important to observe what kind of issues your organization is tackling with and what are lacking to solve the issues. Those observations will help you conduct further analysis.

- Check missions and roles of your organization in the context of the development of your country.
- Also observe what is necessary in your organization to solve the development issues of your workplace. Those observations will help you find reasons to study in Japan.

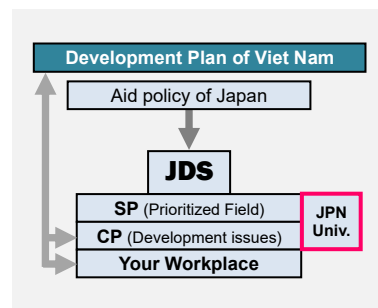




#### (4) University research

As shown in "Framework for Master Program (P5)", the relevant Japanese universities (courses) are designated under each CP. Those universities are selected to offer you sufficient knowledge in order to tackle development issues of your concern. As the universities wish to recruit students with the necessary academic level and high motivation to learn, you need to demonstrate those points in the following way.

- One of the ways to show your self-motivation is to demonstrate how much you know about the university you are applying for.
- Go to the university website to know their location, history, provided courses, the faculty members, etc.
- Find interesting professors, and check their research areas, current activities, their published academic papers, etc.
- Answering Q2 will help you consider why you choose the university. It will also help you to show how much you are willing to study at the university and how much your research proposal is matched with the university.



#### (5) Career plan

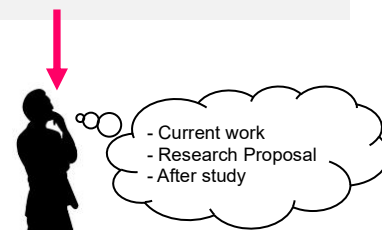
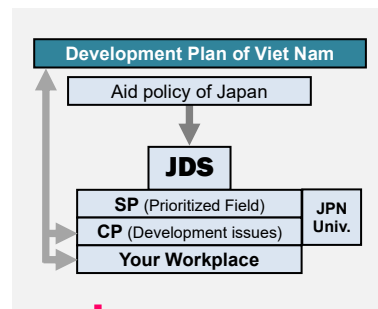
As you can see in Required Documents, you will be required to fill in Required Documents – Short Essays (**Question 1** Responsibilities of your work, **Q2** Reason for Applying the Graduate school / course and **Q3** Future Contribution) and Research Proposal. Those questions are very coherent in the sense that each question asks [who you are / what you are doing now], [what you want to do in Japan] and [what you can / want to do after your study]. So, those questions ask how you relate your career and study in the context of the development of your country. This is a clear tip to answer to those questions in the AF.

- Question 1, 2, and 3 of Short Essays, and Research Proposal are NOT separate questions. They are very coherent.

##### About "Responsibilities of Your Work" (Short Essays – Q1)

Due to lack of understanding of the connections among [Q1], [Q2], [Q3] and Research Proposal, some people do nothing but list up their daily work. As mentioned above, it is important to show your current (or previous) work in the context of development issues in order to bridge your answers to the next questions (Research Proposal and career plan after study).

- Q1 just asks your current and previous work. But, based on your answers in this Q1, the interviewers (The university and OC) try to guess if you can use acquired knowledge in your work after you return from Japan. Therefore, Q1 and Q3 are two sides of the same coin.



##### About the Reason for Applying the Graduate school / course (Short Essays – Q2)

It is very important to gather the information about the Graduate school / course you will apply for and consider why you choose that university to write a Research Proposal (RP). It will be criteria to check the relevance between your RP and your applied university.

##### About contribution after study in Japan (Short Essays – Q3)

You may have a problem in answering to this question about how you will contribute to the development after your study in Japan. Considering the objectives of JDS, this is a very important factor throughout the selection process. Every year, some applicants provide answers such as "I will share my knowledge", "I will teach at educational institutions" and so on. Those are, of course, important. But, if you are a JDS interviewer, would you be attracted by such answers?

- If you have finished the research and analysis as in (2) ~ (4) above, you should be able to identify the needs of your country and organization as well as your tasks to fulfill such needs,
- It is important to layout your future career plan (after your study in Japan) in relation to the needs of your country and organization, which also will be a solid and good reasoning to study in Japan.

##### About Research Proposal

The details about how to write a Research Proposal (RP) is explained in P23. Based on the explanation above, keep in mind that the RP is considered as an extension of your work [Q1], which will also lead to your career plan after your study in Japan [Q3].

#### (6) Research on relevant issues in Japan

The JDS Fellows are to conduct research on development issues of their home countries. In addition, taking into account that they study in Japan, you are also recommended to know in advance, at least, about historical and empirical cases of Japan in your research field.

#### (7) Test preparation

As shown in "Selection Process (P17)", the results of English and Math tests will be reviewed by the universities in the 1<sup>st</sup> selection (Application Documents and RP screening by the universities in Japan) and afterwards.

- It is strongly recommended to prepare for those tests, improving your ability by self-study. You can prepare both tests in advance!
- About IELTS test, get used to the test format using sample test and textbooks, and websites.
- About Math test, question and solution of the past years' test are available at JDS website. Using the past tests, check rules and formulas in school textbooks!

## 6. Guidelines for Writing a Research Proposal

### (1) Guideline for writing a research proposal

In the application for JDS, the research proposal for your Master's thesis should ;

- Address the current issues/problems of the socio-economic development of your country and how to remedy these issues/problems.
- Present a detailed work plan on how and what you will do to achieve the goal of your study.

The research proposal which is submitted for the application is not deemed to be final. It will be revised during the course work in line with the Component. The purpose of the research proposal is to help its readers (faculty members of graduate schools) evaluate the significance and potentiality of your research from the following aspects:

- 1) Does the research proposal address the important policy questions of the applicant's country?
- 2) Does the research proposal show that the applicant is strongly motivated and adequately prepared to implement the research successfully?
- 3) Who will benefit from the result of the research? Will the result of the research contribute to solving or clarifying policy questions which are important for applicant's country?

- 4) Does the research help the applicant to participate in the development process of your country more effectively after the completion of the course?
- 5) Is the applicant's academic background strong enough to implement the research proposal?
- 6) Is the applicant's work experience sufficient to pursue the research? (Not necessary if other application material is good enough to show that the answers are positive.)
- 7) Does the research proposal fit well with the program of the graduate school?
- 8) Are the applicant's research questions academically significant?

The importance of each point above, however, depends on the field of study and the graduate program you are applying for. Some graduate programs may require more specific information about the data and method of analysis. Therefore, it is essential to go through the "University Information" as well as the website of the university carefully before writing your research proposal. Writing a research proposal is the beginning of your research. It is highly recommended that you keep improving your research proposal before departure to Japan after being selected as a JDS Fellow.

### (2) Outline of the research proposal (Example)

<b>Title</b>		Describe the nature of your proposed research clearly. Avoid making it too short or redundant.
<b>Introduction</b>	Background	Position your research theme here to <u>state the significance of your research in the research areas</u> . The literature review is not a part to merely describe preceding studies <u>but to sort out what research has been done, what have been found and what are unknown in your research field</u> . Also consider relevance with development issues and your organization. List the preceding studies in a reference section at the end of your research proposal.
	Literature Review	
	Purpose and Questions	<u>Shape and clarify what you want to achieve by your research</u> . <b>It is recommended to think about research purposes at a higher level not in your daily duties</b> . The research itself is not a purpose. Your research is supposed to contribute to the development of your country and institutional development of your organization. As for the research questions, set your questions in relation to the preceding studies above, development issues of your country and organization, also taking into consideration your research methodologies. <u>With solid research questions, the research methodologies will be clarified accordingly</u> .

<b>Conclusion</b>	<b>Expected Results Significance</b>	Tell the reader the important points to stress and address your future plan. <ul style="list-style-type: none"> <li>• Expected learning/findings from your research.</li> <li>• Describe your future plan on how to utilize your research outcome to solve the issues mentioned in the first part after returning home.</li> <li>• Describe how your research outcome will contribute to the development of the country and the institutional development of your organization.</li> </ul>
	<b>Bibliography</b>	Include all the resources which are used in the writing of the research proposal.

### (3) Warnings about “Plagiarism”

“Plagiarism” is a serious offense in the academic field. Plagiarism means using other person’s ideas and words without explicitly acknowledging the source of that information.

University students including JDS applicants and Fellows are members of the academic and must not commit plagiarism in making a research proposal and thesis. Otherwise, you may be disqualified from the selection, or even be discharged from the university, once the plagiarism is found in your research proposal, or academic work at the university.



**Such cases are deemed plagiarism:**

- Copying from books or articles written by other authors without permission
- Copying from an internet source without referring to the attribution text or information
- Misrepresentation of someone’s work as one’s original

**To avoid plagiarism, you must cite sources and give credit whenever you use:**

- Other person’s idea, opinion, or theory
- Any facts, statistics, graphs, drawings – any pieces of information – that are not common knowledge
- Quotation of other person’s spoken or written words, or
- Paraphrase of other person’s spoken or written words



When you make your research proposal, also pay attention to “Paraphrase”.

Paraphrase is a re-expression of other person’s ideas in your own words. There is an accurate and inaccurate way of paraphrasing.

## 7. FAQ (Frequently Asked Questions)

### Q1. What is the Sub-Program (SP) / Component (CP)?

They are the fields of study determined based on the priority development issues of each JDS recipient country. JDS Fellows are expected to prepare the research proposal in line with the stated issues. Please study your applying Sub-program/Component before application.

### Q2. I can't speak/understand Japanese. Can I apply for JDS?

Yes, you can. Master's programs under JDS are instructed in English. Because of this, English proficiency is more valued than Japanese proficiency.

### Q3. I have already received a scholarship from another country. Am I eligible to apply for JDS?

No. The following persons are NOT eligible to apply for JDS.

- Persons who are currently receiving or is scheduled to receive another scholarship.
- Persons who had already got master's degree in other countries under any scholarship.

(\* However, persons who are studying in master's course or obtained master's degree without foreign assistance in local/foreign universities are eligible.

### Q4. Can I apply for a component which is not relevant to my major at university?

Yes, you can. Your major at university is not of criteria for us to refer to your qualification. Only for Component 3-1: Nagoya University, Kyushu University and Tohoku University, Bachelor of Law is preferable.

### Q5. Where can I get the Application Documents?

Please access JDS website.

Application Documents, Application Guideline (AG) and university information can be downloaded from this website.

### Q6. I graduated from more than 2 universities. Which diploma/transcript should I submit?

If you write down both universities as Educational Background in the Application, please submit both of them.

### Q7. My academic record was officially issued in Vietnamese and English by my university. Does JDS still require a notarized English translation?

No, we do not. Just notarized copy is needed.

### Q8. I lost my university diploma and now I only keep some notarized copies. I cannot get a notarized English translation from them. What should I do?

It is the responsibility of a candidate to collect all necessary documents for application.

### Q9. How do I write a research proposal?

Please refer to "Guidelines for Writing a Research Proposal" (P.23) in this booklet. You can also refer to many literatures about how to make a research proposal on the internet. Please pay attention to avoid "plagiarism".

### Q10. Does JDS accept a handwriting application?

No, only online applications are accepted.

### Q11. Do I need to take English and math test? And do these scores affect the JDS selection?

Yes. Every applicant must take the English examination (IELTS academic test) except for those submitted a qualified English score. Applicants for the following components will be exempted from Math test: Component 1-5: The University of Tokyo, 2-2: Kyoto University, 3-1: Nagoya University, Kyushu University, Tohoku University, 3-2: Ritsumeikan University. The English and math scores will be reviewed by the accepting universities in the document screening and afterwards.

### Q12. If I am suddenly busy on the English examination day, can I take an IELTS test in a different day instead?

In principle, applicants are required to sit for the IELTS test on the designated day. For special cases, please contact JDS Project Office for support on this matter.

### Q13. How can I know each selection result?

JDS Project Office will announce the result of each selection to all candidates via email.

### Q14. Will you give us the university information in detail?

For the information, please refer to the "Accepting University" on JDS website. You can also visit the university's website for more details.

### Q15. Can you tell me the e-mail address of the university professors who are in charge of JDS?

Please firstly contact JDS Project Office for further information. It is not recommended to contact professors directly.

### Q16. I cannot decide on a university. Will you tell me which university is best for me?

No, we cannot. It is your responsibility to decide on a university to apply for. Please check information of "Accepting University" on JDS website carefully and choose the best one that is suitable for your research proposal on your own.

### Q17. Can I change the university after the submission of the documents?

No, you cannot change university after the submission of the documents for any reason.

**Q18. Can I change a graduate school under applied university when selected as a JDS Fellow?**

No, you cannot. The graduate schools are fixed in accordance with the sub-programs and components.

**Q19. If I am selected as a JDS Fellow, can I stay at a dormitory of the school that I apply for?**

It depends on the arrangement of each university. When you are selected as a JDS Fellow, we will inform you more details of accommodation.

**Q20. How should I go to Japan, and how to start to live?**

JICE will support all JDS Fellows during the stay in Japan. Fellows' air-ticket and visa to enter Japan will be arranged by JICE. In Japan, JICE will also assist the Fellows in accommodation hunting and university entrance procedure. JICE will support JDS Fellows all the time from your departure to return.

**Q21. Is JDS a full scholarship?**

Yes. All the costs to study in Japan will be covered by JDS. For further detail, please refer to "Award Benefits" (P.3) in this booklet.

**Q22. Can I extend my stay after the completion of master's program?**

No. All JDS Fellows MUST return to their country by the designated date after graduation, complying with the Pledges required by the JDS Operating Committee as well as the Government of Viet Nam. JDS Fellows have an obligation to return to the belonging organization and contribute to the socio-economic development of the country with acquired knowledge and skills.

**Q23. Can I bring my family to Japan during my scholarship?**

Yes, you can, but you need to wait for three months since you arrive in Japan. JDS Project regulates that you are not allowed to bring your dependents (spouse and child/children) to Japan for three (3) months after your arrival in Japan so that you can fully concentrate on your study. However, some accepting universities have stricter rules regarding the bringing of dependents to Japan, so those rules shall have precedence, and the Fellow shall act in compliance with said rules. No additional expenses for dependents will be covered by JDS project.

## IV. Application Guidelines for Doctoral Program

### 1. Applicant Eligibility

<b>Nationality</b>	Citizens of Socialist Republic of Viet Nam
<b>Age</b>	<b>Not over 45</b> as of April 1st, 2025 (born on/after April 2 <sup>nd</sup> 1979)
<b>Academic Background</b>	<ul style="list-style-type: none"> <li>Be a JDS Returned Fellow (a person who completed Master's Degree under JDS), <u>OR</u> a person who has obtained a Master's Degree from a university in a foreign country (outside of Viet Nam under full-time and formal training)</li> </ul>
<b>Work Experience</b>	<ul style="list-style-type: none"> <li>Be a <b>public employee</b> with at least twelve (12) months at the current organization with social insurance covered by the organization.</li> </ul>
<b>Health Condition</b>	<ul style="list-style-type: none"> <li>Be in good health both physically and mentally Applicants need to take and pass all medical check-up at the time of Interview. This medical check-up is arranged by JDS Project Office. Applicants who cannot take or pass all medical check-up will be disqualified from JDS scholarship.</li> </ul>

<b>Ineligibility</b>	<p><b>A person who falls under any of the following items is NOT eligible to apply:</b></p> <ul style="list-style-type: none"> <li>Those who are currently receiving (or scheduled to receive) another international government scholarship (including other scholarships of Japan).</li> <li>Those who have obtained a doctoral degree or higher in a foreign country under any kind of scholarship.</li> <li>Those who were sent for overseas study by the Government of Viet Nam (including JDS) but could not complete their study or did not report their completion as regulated.</li> <li>Those who were awarded scholarships for overseas study (including JDS) and being in the constraints of compensation training expenses.</li> <li>Military personnel registered on the active list or person on alternative military service.</li> </ul>

#### <Other Conditions>

##### The applicant must:

- Contact and receive a Reference Letter from the expected academic adviser(s) by themselves.
- Present a research proposal relevant to the development issues of their country referred to in the framework of Sub-Programs and Components (See the table for Framework for Doctoral Program on page 6).
- Return and work within Viet Nam for belonging organization at least six (06) years after completing doctor course in Japan in order to make a contribution to the development of Viet Nam through their work in their organizations, complying with the Act of Pledge required by the Ministry of Education and Training. If JDS returned fellows go for Doctor's course during the regulated reinstatement period after completing Master's courses in Japan, the rest of the period will be carried over.
- Complete the course within, and not exceeding, three (3) years. **However, if it is judged that the Doctoral degree is likely to be obtained, the extension up to 6 months will be accepted.**

- ✓ Application Documents with false statements or plagiarism will be immediately disqualified.
- ✓ A result of each selection will be announced to all candidates via email.
- ✓ In principle, reasons for the selection-results will not be disclosed.

### 3. Selection Criteria by OC

JDS aims at fostering future leaders with a good understanding of Japan and are capable of:

- Making policy formulation and decision from a broader perspective by drawing on their advanced knowledge and expertise,
- Leading international discourses on various policy issues on behalf of their countries, and
- Exercising their positive influence within their countries and beyond from the global viewpoints by fully utilizing personal networks developed through this doctoral program,

**Prospective Applicants** must have the potential for becoming future leaders rather than academic researchers who can substantially influence policy affairs. Accordingly, the JDS Operating Committee will evaluate and select applicants based on the following criteria:

## 4. How to Apply

- Application Form (AF) and other designated forms can be downloaded from JDS website.
- All documents written in the language other than English need notarized English translation. (Except for Doc. No 8 & 10)
- Use only **A4** size paper for all documents.
- Do not staple the documents but clip on them.
- Submit a "Letter of Explanation" in case wrong information (e.g., wrong spelling of name, birthday, etc.) is contained in official documents due to administrative errors.
- Make your own extra copy of the Application Documents before submission.

Applicants are required to submit a set of necessary documents in the following manner.

## V. Special Trainings and Events

JDS Program provides the following activities for JDS Fellows and Returned Fellows in addition to their study and research at accepting universities.

### Pre-departure Orientation in Viet Nam

All JDS fellows will attend a pre-departure orientation for one week in Hanoi. During the program, they will be informed about JDS regulations and life environment in Japan to prepare for the departure. In addition, exchange sessions with JICA Viet Nam Office and returned fellows will provide more in-depth information about the development issues and experience of academic and daily life in Japan. Group discussion among JDS fellows in the same components also provide them chances to brainstorm and develop their action plans for period in Japan. Finally, JDS fellows will attend a Send-off Ceremony after the pre-departure orientation.



### Post-arrival Orientation in Japan

The post-arrival orientation is organized for two weeks in Japan to support newly arrived fellows from all JDS countries to adapt to new life in Japan. During the program, JDS fellows will participate in many lectures on leadership, Japanese cultures, safe management, and the above-mentioned Japanese training. They will also attend a Welcome Reception organized by JICE headquarter (with the participation of distinguished guests from JICA headquarter, Ministry of Foreign Affairs of Japan, Embassy of recipient countries in Japan, etc.) In addition, they will be supported to find accommodation, open a bank account, register for National Health Insurance and other procedures to settle their life in Japan.

### Japanese Language Training

Though courses at the accepting universities are taught in English, before and after the arrival in Japan, Japanese language training courses are provided to the fellows with the basic lessons on Japanese characters (hiragana, katakana, and kanji), greetings, and how to introduce themselves, etc. In addition, they can deepen their understandings of Japanese culture, lifestyle and manners, and learn the procedures necessary for staying in Japan such as government office, post offices, and banks, etc.

### **Asian Government Leaders Networking Event**

This special event aims to establish long-term cooperative relationships between JDS Fellows and Japanese government officials by providing opportunities of interaction and mutual learning. JDS Fellows participate in the event and expand their personal networks with Japanese government officials, who would become their counterparts in the future.



### **Potluck Party Event**

In addition to networking events in the academic/professional fields, a potluck party for international students studying at different universities under different projects is organized annually. Participants wearing unique traditional costumes of their own countries, bringing their traditional cuisines and enjoying the friendly conversation create a very cozy atmosphere at the event.

### **Pre-returning Program**

Pre-returning Program is held around 6 months before JDS fellows return to their home countries, inviting all fellows from accepting universities. During this event, they have opportunities to attend a series of programs, including leadership programs and a special lecture given by a prominent scholar. It also helps them build a network with JDS fellows from various countries.

### **JDS Follow-up Seminar**

The network and collaboration between universities and returned fellows as well as between returned fellows themselves are much emphasized by JDS Program. JDS Follow-up Seminar, therefore, is organized annually with participation from professors of accepting universities and JDS returned fellows to share and update the progress and results of academic activities conducted by accepting universities in Japan, professors and returned fellows. The event will help to reconnect and strengthen the connection between Viet Nam and Japan sides even long after the graduation of returned fellows.

### 1. Please tell us your career path after JDS.

I got involved in the joint research between National Economics University (NEU) and GRIPS (National Graduate Institute for Policy Studies) at Viet Nam Development Forum Hanoi in 2003 after studying at Hitotsubashi University under JDS. During the joint research project, I could meet Prof. Kenichi Ono of GRIPS who has been my mentor. I obtained PhD in public policy at GRIPS in 2008 using the MEXT scholarship. In 2012, I was promoted to associate professor. In early 2014, I was promoted to be Director of Institute of Public Policy and Management at National Economics University.

### 2. What was the biggest harvest during study at Hitotsubashi University under JDS?

I happened to find my lifetime theme, "Population and Social Security" when I was helping APPP professors in preparing an international conference on pension reforms in Asian countries in 2002. At that time, only a few studies on aging and pension issues for Viet Nam. I have deepened my knowledge and experience on this theme and become an expert in the area of aging and social security in Viet Nam.

### 3. How have you utilized your personal connections obtained in Japan?

I maintain strong ties with Japan and conduct joint studies with Japanese universities. One of the biggest advantages of studying in Japan is human network. I could develop the human network with many experts not only from Japan but also from other Asian countries in the field of population and social security while I was studying at Hitotsubashi and GRIPS. Even after returning to Viet Nam, we frequently see each other somewhere in Asia for international conferences or joint researches. These opportunities make our ties stronger.

### 4. Besides study, what have you learnt from Japan?

In addition to academic knowledge, I have gained a lot of lessons learnt from Japanese people such as respect for others, team work, detailed planning before doing, and time management. For example, as we are working under very tight schedule and quality pressures, if you are late for the meeting, you take time of others. We need to be punctual. I share such an important lesson to my students.

### 5. Can you share alumni activities of Hitotsubashi University, APPP?

Hitotsubashi University, APPP holds a seminar in Hanoi every year and I have attended these activities as the chairman of alumni. Whenever our professors visit Hanoi, we organize gathering dinners together with other graduates. We have maintained the strong network among the graduates, and we support each other in our work.

### 6. What is your future career plan?

I would like to strengthen the collaboration with Japanese universities to establish a higher education program, such as a master's program in public policy or social security. In addition, I will continue to contribute to the Vietnamese society by utilizing outcomes of my research for policy advocacy.

**1. Please let us know your career path after JDS.**

After 4 years working experience as director of Center for Ecotourism and Environmental Education, Bach Ma National Park, I went to Japan for studying at TUAT under JDS in 2004. I returned to Bach Ma National Park in 2006 and was promoted to vice director in 2009. I am currently taking charge of management of most of the activities in the national park such as ecotourism, environmental education, community development, negotiation, etc. Since 2012, I have taken charge of some of the nature conservation which is one of the most important activities in the national park.

**2. How have you utilized your personal connections obtained in Japan?**

I applied for the JICA Grassroots Technical Cooperation Project jointly with my academic supervisor at TUAT. The project started in 2008 and finished in 2013. I was engaged in the implementation of the project for improving rural living and nature conservation by multipurpose use of charcoal and wood vinegar in the Bach Ma National Park. I could obtain both knowledge and personal connections at TUAT. I try to maintain and develop the network I gained in Japan and contribute to improvement of the bilateral relationship between Viet Nam and Japan. These days, Bach Ma National Park has accepted the on-site field research exercise of the JICA field study program for international cooperation of university students.

**3. What are the advantages and merits of JDS?**

What I have obtained is not limited to the academic knowledge. I learned a lot from the Japanese mindset toward work and daily behavior. For example, I realized the importance of the communication in establishing and developing cooperation and partnership with others.
