Japan International Cooperation Agency (JICA) Vietnam Office presents its compliments to the your esteemed agency and has the honor to inform of the followings as an announcement of JICA-related academic opportunity for high-quality human resource development of the Government of Vietnam (GOV).

Under JICA's scheme of Knowledge Co-creation Program (KCCP) as a part of Japan's ODA based on bilateral agreement between the Government of Japan (GOJ) and respective partner governments, the KCCP (Long-term) program titled **GX Human Resources Development for Energy Sector** will be implemented for the enrolment of 2026 (please refer to the attached General Information Brochure for details).

The program is designed provide scholarships for successful candidate to pursue Master or Ph.D. degrees in Japanese universities. Application procedures of the program include the following steps:

Step 1: Screening and Matching

Upon receiving nomination and application documents from relevant organizations in partner countries, JICA and the Japanese university proceed for screening and matching. A set of application documents must be submitted to JICA Vietnam Office by December 1, 2025

Upon receiving nomination and application documents from relevant organizations, JICA will screen application documents.

Step 2: University Application


This application process is conducted by each Japanese university. Applicants must apply through the procedures designated by respective university.

Step 3: Official Application to JICA

This is an application process after each applicant is accepted by the respective Japanese university. JICA will decide the final candidate(s) and request for Government's endorsement as an ODA procedure.

Accordingly, a final Vietnamese candidates must be officially approved by the Ministry of Finance (MOF) and JICA. At this stage, each candidate is requested to submit a set of appliation documents to JICA Vietnam Office through his/her Line Agency to MOF by the deadline to be notified by JICA Office.

The overall application flow is as below:
